

## PRIVACY POLICY

Last updated: December 1, 2021

This Privacy Policy describes how the Application uses and interacts with Your data and tells You about Your privacy rights and how the law protects You.

The Application does not collect any of your personal info. Any information used by the Application to identify you is previously acquired during registration for the ARCTOS conference.

### Interpretation and Definitions

#### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### Definitions

For the purposes of this Privacy Policy:

- **Account** means a unique account created for You to access our Application or parts of our Application.
- **Affiliate** means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.
- **Application** means the software program provided by the Company downloaded by You on any electronic device, named ProLead
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to ARCTOS Technology Solutions, LLC, 1270 North Fairfield Road, Dayton, OH 45432.
- **Country** refers to: Ohio, United States
- **Device** means any device that can access the Application such as a computer, a cellphone or a digital tablet.
- **Service Provider** means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Application, to provide the Application on behalf of the Company, to perform services related to the Application or to assist the Company in analyzing how the Application is used.
- **You** means the individual accessing or using the Application, or the company, or other legal entity on behalf of which such individual is accessing or using the Application, as applicable.

### Types of Data Collected

#### None

The Application stores information collected during conference registration, including name, organization, email, and phone number. Although the Application requests camera access to add leads, we do not collect any data from the camera. You can disable camera access through Your device settings at any time. All data used in the Application was previously acquired during the conference registration process.

### Camera Usage

The Application will request use of the camera when You attempt to add a lead. If you allow camera access, the Application will begin to use the camera to detect QR Codes placed in front of the camera. We do not collect any data from the camera during this process. When a QR Code is read from the camera, it will retrieve the attendee information that we already collected during conference registration and stop the camera.

### **Children's Privacy**

Our Application does not address anyone under the age of 13. We do not knowingly collect personally identifiable information from anyone under the age of 13. If You are a parent or guardian and You are aware that Your child has provided Us with Personal Data, please contact Us. If We become aware that We have collected Personal Data from anyone under the age of 13 without verification of parental consent, We take steps to remove that information from Our servers.

If We need to rely on consent as a legal basis for processing Your information and Your country requires consent from a parent, We may require Your parent's consent before We collect and use that information.
